1. To attend the orientation meeting during the summer (date to be announced);
2. To pay the annual dues of \$450 (Associates) or \$475 (Barristers and Masters), or \$100 (law student). The first \$85 is due by June 18, 2018, to pay for National American Inns of Court Dues (Law Students excepted). The balance can be paid as follows: \$100 (Law Student), \$365 (Associates), or \$390 (Barristers and Masters) paid in full by September 1, 2018. If you wish to split your balance payment into two installments, the first payment will be due September 1, 2018. A \$25 fee will be added to your second payment (due December 15, 2018).
